The Consulate General of India, Jeddah invites Sealed Tenders/bids from registered Pilgrim Transport Companies for short term leasing of 12 coaster buses not older than 2022 model with two Indian (preferably) drivers on each coaster bus and refueling of gasoline etc. for Haj operation during Haj -2026.

2. Interested and eligible Pilgrim Transport companies may submit their bids in accordance with the procedure outline in the Tender Document. The bids should be dropped in the Tender Box marked **“Tender Box”** placed at the **Reception of the Consulate General of India, Tahlia Street, Jeddah**. The offer must be submitted no later than **31.12.2025 by 1700 hrs..**

**NOTICE INVITING TENDER**

Consulate General of India, Jeddah, invites sealed Tenders/bids from the registered Pilgrim's Transport Companies for short term leasing of 12 Coaster Buses not older than 2022 model with two Indian (preferably) drivers on each bus, Gasoline/Diesel, without mileage restriction and comprehensive insurance having requisite license/registration/permissions etc., with local compliance authorities.

Title of Work:	Short terms leasing of 12 coaster buses not older than 2022 model (The seating capacity 25 or more with dimension Length 6,990 mm (6.99 meters) – Width 2,080 mm (2.08 meters) – Height 2,635 mm (2.63 meters), the bus length should not exceed over 7 meters or equivalent
Period for which service is required:	15 <sup>th</sup> Shawwal, 1447 H to 15 <sup>th</sup> Moharram, 1448 H (corresponding to 03.04.2026 to 30.06.2026)
Purpose:	For movement of officials deputed by Government of India on Haj duty & other staff for movement in/between Jeddah, Makkah & Madinah including <b>Mashaer Region</b>

Earnest Money Deposit	<b>SAR 50,000/-</b> (details mentioned in point No. 3)
General Requirements	-Only registered Pilgrim Transport Companies registered with Naqaba Sayyarat (General Car Syndicate) and who can get necessary movement permits issued to the drivers by Ministry of Interior through (Elm) or concerned Saudi authorities for movement between, Makkah, Madinah and Jeddah including <b>Mashaer Region</b> during the leased period
	Fueling (gasoline) shall be managed by the company without any mileage restriction
	Comprehensive insurance coverage is mandatory
Functional Requirement No. 1	Round the clock service with two Indian (preferably) drivers on each unit (12 hrs duty)
Functional Requirement No. 2	Besides, the company is also required to provide 45-49 seater buses of pilgrim transport companies registered with Naqaba Sayyart (General Car Syndicate) for transporting about 700 officials from Jeddah Airport to Makkah, Makkah to Madinah, Madinah to Makkah & Makkah to Jeddah Airport on different dates as per the requirement of the Consulate

**2.1 Auto extension of critical dates:** If number of bids received is found to be less than 03 (three) on the end date of bid submission, then the last date of bid submission and bid opening date of the Tender will be automatically extended for a period of 03 (three) working days ending at 17.00 hrs. The auto extension shall work on the basis of number of bids received only.

**2.2** If any of the above extended dates falls on a Holiday i.e. a non-working day then the same is to be rescheduled to the next working day.

**2.3** This extension will be also applicable in case of receipt of zero bid.

**2.4** After extension, the tender shall be opened irrespective of available number of bids on the extended date of opening of tender, even less than 3.

**3. Bid Security/Earnest Money Deposit (EMD):** The bidder shall furnish, as part of his/her bid, a Bid Security/**Earnest Money Deposit of SAR 50,000/-** as shown in para 1 above **by means of Account Payee Demand Draft, Banker's Cheque, Fixed Deposit Receipt or Bank Guarantee** issued from the local Saudi commercial bank in favour of "**Consulate General of India, Jeddah**". Bids submitted without a valid Bid Security/EMD shall be deemed non responsive and will be summarily rejected by the Consulate. The Bid Security/EMD of the successful bidder may be retained and adjusted against the Performance Security.

**3.1** The Bid Security/Earnest Money may be forfeited:

(a) if the Bidder withdraws the Bid after Bid opening during the period of Bid validity

OR

(b) in the case of a successful Bidder, if the Bidder fails within the specified time limit to:

(i) sign the Agreement; OR

(ii) Furnish the required Performance Security/ Security Deposit.

**3.2** Additionally, the Consulate shall ban such defaulting contractor from participating in future tenders of the Consulate for a period of minimum one year.

**3.3** The Bid Security/EMD deposited with the Consulate will not carry any interest.

**3.4** The Earnest Money/ Bid Security deposited shall be discharged when the successful Bidder has signed the Agreement and furnished the required Performance Security. The bid security deposited may be adjusted against the Performance security at bidder's choice.

**4. Refund of Security/EMD:** If Bid Security/EMD is paid by the bidder then the EMD of rejected bidders will be refunded (except the cases where EMD is to be forfeited).

**4.1** In case the tender is cancelled the EMD of all the participating bidders will be refunded unless it is forfeited by the Consulate.

**4.2** If the bidder withdraws his/her bid (i.e. before the end date of submission of tender) then his/her EMD will be refunded automatically after the opening of tender.

**5. Performance Security:** The Performance Security, amounting to **5%** of the contract value, must be submitted by the successful bidder within 15 days of issuance of Work Order by the Consulate. It shall be in the form of an **Account Payee Demand Draft, Banker's Cheque, Fixed Deposit Receipt, or a Bank Guarantee** issued by a local Saudi commercial bank in favour of "**Consulate General of India, Jeddah. The Performance Security must remain valid for a period of ninety (90) days beyond the completion date of the Haj season 2026.**

**5.1 Refund of Performance Security:** The refund of security deposit shall be subject to Consulate's right to deduct penalties as determined on account of deficiency in services and non-compliance of terms and conditions of the agreement with the successful bidder.

**6. Pre-Bid Meeting:** The purpose of the pre-bid meeting is to clarify the issues and to answer the questions on any matter that may be raised at that stage regarding Tender. Non-attendance at the pre-bid meeting will not be a cause for disqualification of a bidder and it shall be presumed that the bidder does not require any clarification. The pre-bid meeting shall be held in Consulate General of India, Jeddah on the scheduled date & time. The bidder may also seek clarification over official e-mail within the specified period.

**7. Eligibility of the bidder:** The invitation for bid is open to all bidders including an individual, proprietorship firm, partnership firm, company registered with the Chamber of Commerce/Zakat, Tax and Customs Authority (ZATCA)/appropriate licensing authority of the Kingdom of Saudi Arabia.

**8. General Essential Requirements:** In order to qualify in the tender, the Bidders have to accept all the Terms and Conditions of the Tender Document unconditionally. The tenderer shall closely study the Tender Document.

**8.1** Each Bidder shall submit only one Bid, either individually, or as a proprietor, or as a partner in a partnership firm. **A Bidder who submits or participates in more than one Bid will cause all the proposals with the Bidder's participation to be disqualified.**

**8.2** The successful Bidder will be expected to complete the Work(s) by the Intended Completion period specified in the Tender document.

**9. Submission of bid:** Technical and Financial bids must be submitted in two separate sealed envelopes with "Technical Bid" & "Financial Bid" clearly mentioned on the envelopes. Both the envelopes should be placed in one large duly sealed envelope. Name of the Tender, Tender Reference No., Name and address, e-mail mobile number of the bidder should be written on the larger envelope containing the sealed envelopes with Technical & Financial bids respectively.

a. **Technical Bid:** Technical bid (in a sealed envelope) consisting of following documents/details (Self attested and duly stamped)

- Copy of valid commercial license and registration
- Copy of license issued by Transport General Authority (TGA), KSA
- Copy of license issued by the General Car Syndicate (Naqaba Sayyarat)
- Profile of the company, also reflecting experience in the field of transportation
- The total number of coaster buses in the fleet and their details or proof of leasing of coaster buses.
- Istamarah copies of coaster buses being offered, or
- Proof of having leased at least 12 coaster buses in the preceding Haj year.
- Copy of VAT Registration
- Original EMD **SAR 50,000/-**
- Copy of Company's IBAN letter
- Drivers on the sponsorship of the company, hired through Ajeer or holders of Temporary Haj Permits are only allowed and undertaking to the effect is required to be submitted.
- Annexure-I (duly signed and stamped)

***Note:- If any of the aforementioned documents are submitted in Arabic, an "Official English Translation" of each document must be provided concurrently.***

b. **Financial bid:** The financial bid containing the Bill of Quantity to be quoted by the bidder in the following format. **The rates quoted by the bidder should be exclusive of VAT. The financial bid which is incomplete and not submitted as per instruction given in this document is liable for rejection.** The rates and prices shall be quoted by the Bidder entirely in Saudi Riyal only.

The financial bid must be submitted on the company's official letterhead, duly signed and stamped by an authorized representative of the company.

## 9.2 Disqualification Due to Overwriting or Zero Bid.

Bidders are advised that any overwriting, alterations, or submission of a zero (0) bid in the financial bid shall lead to automatic disqualification. All entries in the Bid must be clear, unambiguous, and duly filled in accordance with the instructions provided in this Tender Document.

## 10. Opening of bids:

a) A Tender Evaluation Committee (TEC) of the Consulate General of India, Jeddah will open the bids on **04.01.2026** at **11:00** hrs. in the Consulate. Representatives of the bidders may attend the bid opening.

b) TEC will first evaluate the Technical bids and, technically qualified bidders will be informed of TEC's decision and invited to be present for the opening of Financial bids. Thereafter, financial bids of only technically qualified bidders will be opened, in presence of representatives of technically qualified bidders. The EMD of the remaining bidders who could not meet the requirements of Technical bid would be returned after the bidding process.

(c) In case more than one company quotes the same L1 rate, those companies will be asked to resubmit financial bids (only rates lower than the originally quoted rates will be entertained).

**10.1 Decision of L1 bidder & Issue of work order:** The L1 bidder will be decided on overall Bid Value (Excluding VAT). **If L1 bidder backs out, the bidder will be debarred from participating in tenders floated by the Consulate General of India, Jeddah for minimum one (1) year.**

**10.2** The approval for award of work to L-1 Bidder will be accorded by the Competent Authority. Only after such approval, the Letter of Acceptance/Work order to the L-1 Bidder will be issued.

**10.3** Upon issuance of the Work Order by the Consulate, the successful tenderer shall execute the contract agreement within 15 days or by the date/time specified by the Consulate, whichever is earlier. **Failure to execute the contract within the stipulated period shall result in cancellation of the Work Order.** Furthermore, the

Consulate reserves the right to debar the bidder from participating in future tenders for a minimum period of 12 months, and the EMD/Bid Security shall be forfeited.

**11. Bid Validity:** The validity period of the tenders shall be from the date of issue of work order to the end of Haj Season i.e. 15<sup>th</sup> Muharram 1448 H (corresponding to Gregorian 30.06.2026). **The tenderer shall not, during the said period, revoke or cancel the tender or alter the tender or any terms/conditions thereof.** In case the tenderer violates to abide by this, the Consulate will be entitled to take suitable action.

**12. Contract Agreement Document (s):** This Tender Document shall be deemed to be part of the Contract Agreement.

**13. Sub-letting of work:** No subletting/out sourcing of work by the successful bidder is permissible.

**14. Payment:** Payment to the companies (successful bidders) for execution of the work will be made either through bank transfer or account payee cheque after the completion of works/service and submission of a valid VAT invoices.

**15. Canvassing in Tender:** Canvassing in connection with the tenders in any shape or form is strictly prohibited and tenders submitted by such tenderers who resort to canvassing shall be liable for rejection

**16. Postponement or cancellation of tenders:** The Consulate reserves the right to postpone the date of receipt and opening of tenders or to cancel the tenders **without assigning any reason whatsoever.**

I/We do undertake that I/We shall hire drivers (preferably Indian) and shall get necessary permits issued to the drivers and Vehicle by Ministry of Interior through (Elm) or concerned Saudi authorities for movement between **Jeddah, Makkah, Madinah** and **Mashaer Region** during the leased period.

8. I do hereby undertake that all the information being submitted by me/us is genuine, authentic, true and valid on the date of submission of tender and if any



information is found to be false at any stage of tendering or contract period, I/We will be liable to the following penal actions apart from other penal actions prescribed elsewhere in the tender document.

- a. Cancellation of my/our bid/contract (as the case may be)
- b. Reasonable action as deemed fit by the Consulate

9. That I/we accept all terms and condition of the tender document. I/We do not have relationship with any other participating Bidders, directly or through common third parties, that puts us in a position to have access to information about or influence on the bid of another Bidder.

10. I do undertake that if any information and document submitted is found to be false/ incorrect at any time, Consulate may cancel my/our Bid and action as deemed fit may be taken against me/us, including termination of the contract, forfeiture of all dues and banning of our firm and all partners of the firm etc as per the tender document for which I/We shall have no claims against Consulate.
