HIRING OF TRANSPORTATION FOR HAJ 1443 H - (2022 G)

For the forthcoming Haj-2022, we intend to hire the below mentioned vehicles for the period indicated against each:

1. Eight Buses (45-49 seater) of 2019 and above model

- i. Requirements: With Indian Drivers, Gasoline refueling, having comprehensive insurance
- ii. Purpose: To be available at the Consulate's disposal for use by Indian Officials during the Haj-week to ply in Mashaer Region and Inter-city route.
- iii. Period: Haj Week 7-14th Zul Hijjah 1443 H (*corresponding to 6th July to 13th July 2022*)
- iv. Supplier's Eligibility: Only the registered Pilgrim Transport Companies having valid entry permits issued by the General Cars Syndicate, Makkah will be considered.

2. Eight Coaster Buses of 2019 and above model

- i. Requirements: With two Indian drivers on each bus (with 12 hrs each duty), Gasoline refueling, having comprehensive insurance, free mileage, round-the-clock service
- ii. Purpose: To be available at the Consulate's disposal for use by its officials; to ply in/between Jeddah-Makkah-Madinah as per requirement.
- iii. Period: 20th Shawwal 1443 to 20th Moharram 1444 H (*corresponding to 21st May 2022 to 18th August 2022*); including during the core Haj period 1-12th Zulhijjah 1443 H.
- iv. Supplier's Eligibility: Only the registered Pilgrim Transport Companies having valid entry permits issued by the General Cars Syndicate, Makkah will be considered.

3. 07 Sedan cars of 2019 and above model

- i. Requirements: With Indian drivers (*with minimum 15 hrs duty per day per vehicle*), having valid comprehensive insurance, gasoline refueling, and free mileage
- ii. Purpose: To be available at the Consulate's disposal for use by its officials; to ply in/between Jeddah-Makkah-Madinah as per requirement.
- iii. Period: 20th Shawwal, 1443 to 20th Moharram, 1444 H corresponding to 21st May 2022 to 18th August, 2022 (*including during core Haj week between 1-12th Zul Hijjah, 1443 H*).
- iv. Supplier's Eligibility: Registered Car Rental Companies based in Jeddah/Makkah which have necessary permits issued by Jawazat to ply between Jeddah-Makkah-Madinah

4. 20 Sedan cars of 2019 and above model

- i. Requirements: Without drivers; having valid comprehensive insurance, gasoline refueling, and free mileage
- ii. Purpose: To be available at the Consulate's disposal for use by its officials; to ply in/between Jeddah-Makkah-Madinah as per requirement.
- iii. Period 20th Shawwal 1443 to 20th Moharram 1444 H corresponding to 21st May, 2022 to 18th August 2022 (*including during core Haj week between 1-12th Zul Hijjah, 1443 H*).
- iv. Supplier's Eligibility: Registered Car Rental Companies based in Jeddah/Makkah

5. Two GMC of latest model

- i. Requirements: With Indian drivers, having valid comprehensive insurance, gasoline refueling, and free mileage
- ii. Purpose: To be available at the Consulate's disposal for use by Officials; to ply in/between Jeddah-Makkah-Madinah as per requirement.
- iii. Period 20th Shawwal 1443 to 20th Moharram 1444 H corresponding to 21st May, 2022 to 18th August 2022 (*including during core Haj week between 1-12th Zul Hijjah, 1443 H*).
- iv. Supplier's Eligibility: Registered Car Rental Companies based in Jeddah/Makkah which have necessary permits issued by Jawazat to ply in/between Jeddah-Makkah-Madinah

6. PURCHASE OF VEHICLE INSURANCE FOR HAJ 1443 H - (2022 G)

- i. Requirement: Comprehensive insurance for 12 vehicles
- ii. Vehicle: 12 Toyota Hiace used as Ambulance vans during Haj season.
- iii. Models: 2015- 3 vehicles; 2016- 2 vehicles; 2017- 3 vehicles; 2018- 3 vehicles

Bidder's Eligibility: Companies with license to provide insurance services

DOCUMENTS TO BE SUBMITTED IN A SEALED ENVELOPE:

- i. For buses and Coaster buses- Proof of Registration with General Cars Syndicate Makkah is compulsory;
For sedan cars and GMC- Proof of having obtained Jawazat permits to ply between Jeddah-Makkah-Madinah
- ii. For vehicles required with Indian drivers (as per details above), proof of having Indian drivers (like Iqama copy of Indian drivers, etc.) is required
- iii. Registration details of Car Rental Companies

How to submit bids:

Bids should be submitted in a big sealed envelope which contains two separately sealed envelopes:

- i. Technical Envelope: containing technical documents; and
- ii. Quote Envelope: another containing the price quote.

The big sealed envelope (with two separately sealed envelopes inside) should be submitted to Vice Consul (Haj), Consulate General of India, Behind National Commercial Bank, Tahaliya Street, Jeddah

Last date of submission of bids: 25 April 2022 by 17:00 hrs
