**ADVERTISEMENT FOR APPOINTMENT OF PART-TIME YOGA TEACHER**

Consulate General of India, Jeddah invites applications from trained Yoga Instructors/Teachers to teach Yoga at Consulate General of India, Jeddah on part-time basis (1 hours on each working day). The Instructor/ Teacher will also be required to contribute in outreach activities at other venues related to Yoga organised by CGI, Jeddah such as seminars, workshops and International Day of Yoga. An honorarium of SAR 150.00 per hour of class would be paid to the Instructor/Teacher subject to a maximum of 20 hour of classes in a month. The engagement would be on contractual basis, initially for a period of 1 year which can be extended for further period of 1 years on the basis of outstanding work, recommendation of the Consul General and approval of Indian Council for Cultural Relations (ICCR).

**Total number of Post:** One Post of Yoga Instructor/ Teacher.

**Essential Qualifications and Experience:** (1) candidate should be a citizen of Saudi Arabia or having Non-Resident Indian (NRI) status with valid work permit.

(2) candidate should be fluent in English and Arabic.

(3) candidate should have a minimum of 3 years degree with 3 years of experience or 2 years diploma/certificate or training in the field of Yoga or a minimum period of 2 years from renowned institute/Guru with 4 years of experience.

**Desirable Qualifications:** (1) Experience in giving performance /lecture demonstrations on Yoga.

(2) Sound knowledge in use of computer including recording /downloading audio/video, mixing and editing video from the YouTube/Internet

**Age limit:** Between 25 (Twenty-Five) and 50 (Fifty) years at the time of application.

**Document verification:** No document is required to be sent with the application form. All educational and qualification & documents shall be verified at the time of interview. Any false information may lead to cancellation of his/her candidature and in the absence of mandatory documents(s) his/her interview will not be held.
