### **Tender Document for short leasing of 5 small sedan cars of latest model for Haj 1445 H – 2024 G**

**Brief of the work:** Consulate General of India, Jeddah, invites sealed quotations from the eligible bidders for short leasing of 5 Small sedan Cars of latest model with drivers, refilling of Gasoline, free mileage & Insurance etc., having requisite license/registration/permissions etc., with local compliance authorities. Quotations are required to be submitted along with the proof of permits issued by Jawazat during the previous year and sponsorship of Indian drivers.

<i>which service is required:</i>	(corresponding to 24.04.2024 to 21.07.2024) including core Haj period 7-12 <sup>th</sup> Zul Hijjah
<i>Eligibility of the bidder:</i>	Only registered car companies based in Jeddah/Makkah/Madinah which have necessary permits issued by Jawazat to ply between Jeddah-Makkah-Madinah. The job will be assigned only to the first party who possesses the fleet and drivers registered in the name of the company and tender submitted should also be in the same name. No outsourcing is allowed.
<i>Purpose:</i>	For movement in Makkah, Madinah & Jeddah as per the Consulate's requirements

**\*EMD submitted if found less than 5% of the total estimated value, the bid submitted will be rejected as non-responsive.**

**\*Only Certified Cheque issued by the local Saudi bank is accepted as EMD and no other cheque will be accepted. In case of other kind of cheque, if submitted, the bid will be rejected as non-responsive.**

**\*EMD certified cheque of 5% of the total estimated value issued by the local Saudi bank to be submitted separately for each item, if submitted combine, the bid submitted will be rejected as non-responsive.**

**2.1 Auto extension of critical dates:** If number of bids received is found to be less than 03 (three) on the end date of bid submission, then the last date of bid submission and bid opening date of the Tender will be automatically extended for a period of 03 (three) working days ending at 17.00 hrs. The auto extension shall work on the basis of number of bids received only.

**2.2** If any of the above extended dates falls on a Holiday i.e. a non-working day then the same is to be rescheduled to the next working day.

**2.3** This extension will be also applicable in case of receipt of zero bid.

**2.4** After extension, the tender shall be opened irrespective of available number of bids on the extended date of opening of tender, even less than 3.

**3. Earnest Money Deposit (EMD):** The bidder shall furnish, as part of his bid, a Bid Security/**Earnest Money of 5%** the estimated value of tender as shown in para 1 above **by means of Certified Cheques issued by the local Saudi bank separately for each item.** Any Bid not accompanied by an acceptable Bid Security/EMD shall be summarily rejected by the Consulate as non-responsive. The bid security/EMD, of the successful bidder may be retained and adjusted with performance security/security deposit.

**3.1** The Bid Security/Earnest Money may be forfeited:

(a) if the Bidder withdraws the Bid after Bid opening during the period of Bid validity

OR

(b) in the case of a successful Bidder, if the Bidder fails within the specified time limit to:

(i) sign the Agreement; OR

(ii) Furnish the required Performance Security/ Security Deposit.

**3.2** Additionally, the Consulate shall ban such defaulting contractor from participating in future tenders of the Consulate for a period of minimum one year.

**3.3** The Bid Security/EMD deposited with the Consulate will not carry any interest.

**3.4** The Earnest Money/ Bid Security deposited shall be discharged when the successful Bidder has signed the Agreement and furnished the required Performance Security. The bid security deposited may be adjusted against the Performance security at bidder's choice.

**4. Refund of EMD:** If EMD is paid by the bidder then the EMD of rejected bidders will be refunded at any stage (except the cases where EMD is to be forfeited).

**4.1** In case the tender is cancelled then EMD of all the participating bidders will be refunded unless it is forfeited by the Consulate.

**4.2** If the bidder withdraws his/her bid (i.e. before the end date of submission of tender) then his/her EMD will be refunded automatically after the opening of tender.

**4.3** At the option of the Bidder, the EMD of successful Bidder (on the Award of Contract) will be retained by the Consulate and will be adjusted to Performance Security Deposit.

**5. Performance Security/Security Deposit:** Performance Security to be submitted at the award of work should be **3%** of the contract amount and should be submitted by the successful bidder within 15 days of issuance of work order by the Consulate in the form of Bank Guarantee. **It should remain valid for a period of sixty days beyond the date of completion of the work.**

**5.1 Refund of Performance Security:** The refund of security deposit shall be subject to Consulate's right to deduct/appropriate its due against the successful bidder.

**6. Pre-Bid Meeting:** The purpose of the pre-bid meeting is to clarify the issues and to answer the questions on any matter that may be raised at that stage regarding Tender. Non-attendance at the pre-bid meeting will not be a cause for disqualification of a bidder and it shall be presumed that the bidder does not require any clarification. The pre-bid meeting shall be held in Consulate General of India, Jeddah on the scheduled date & time. The bidder may also seek clarification over phone within the specified period.

**7. Eligibility of the bidder:** The invitation for bid is open to all bidders including an individual, proprietorship firm, partnership firm, company registered with the Chamber of Commerce/Zakat, Tax and Customs Authority (ZATCA)/appropriate licensing authority of the Kingdom of Saudi Arabia.

**8. General Essential Requirements:** In order to qualify in the tender, the Bidders have to accept all the Terms and Conditions of the Tender Document unconditionally. The tenderer shall closely study the Tender Document.

**8.1** Each Bidder shall submit only one Bid, either individually, or as a proprietor, or as a partner in a partnership firm. **A Bidder who submits or participates in more than one Bid will cause all the proposals with the Bidder's participation to be disqualified.**

**8.2** The successful Bidder will be expected to complete the Work(s) by the Intended Completion period specified in the Tender document.

**9. Submission of bid:** Technical and Financial bids must be submitted in two separate sealed envelopes with “Technical Bid” & “Financial Bid” clearly mentioned on the envelopes. The e-mail & mobile numbers of bidder should be written on the envelope containing the Technical & Financial bids.

**a. Technical Bid:** Technical bid (in a sealed envelope) consisting of following documents/details:

- Copy of valid license and registration
- Profile of the company, also reflecting experience in the field of transportation

b. **Financial bid**: The financial bid containing the Bill of Quantity should be quoted by the bidder in the following format. **The rates quoted by the bidder should be exclusive of VAT. The financial bid which is incomplete and not submitted as per instruction given in this document is liable for rejection.** The rates and prices shall be quoted by the Bidder entirely in Saudi Riyals only.

## 10. **Opening of bids**:

a) A Tender Evaluation Committee of the Consulate General of India, Jeddah will open the bids on **21.02.2024 @ 14:00** hrs in the Consulate. Representatives of the bidders may attend the bid opening.

b) **In case of more than one company quoting the same L1 rate, those companies will be asked to resubmit financial bids** (only rates lower than the original quote will be entertained) for those items in a sealed envelope by 28.02.2024 (17:00 hrs).

**10.1 Decision of L1 bidder & Issue of work order**: The L1 bidder will be decided item-wise and not of overall Bid Value. The ranking of the bidders will be decided based on rates quoted by the bidders, item-wise excluding VAT. **If L1 bidder backs out, the bidder will be debarred from participating in tenders floated by the Consulate General of India, Jeddah for minimum one (1) year.**

**10.2** In case the L1 Bidder fails to comply with the terms and conditions of the tender, then the L-2 Bidder will become L-1 Bidder.

**10.3** The approval for award of work to L-1 Bidder will be accorded by the Competent Authority. Only after such approval, the Letter of Acceptance/Work order to the L-1 Bidder will be issued.

**10.4** On receipt of Letter of Acceptance (LOA)/Work Order of the tender issued by the Consulate, the successful tenderer shall execute the contract agreement within 7 days. **Failure to enter into the required contract within the specified period in the work order shall entail cancellation of LOA/work order.** In addition, the Consulate may debar the bidder from participating in future bids for at least 12 months.

11. **Bid Validity**: The validity period of the tenders shall be from the date of issue of work order to the end of Haj Season i.e. 15<sup>th</sup> Muharram 1446 H (corresponding to Gregorian 21.07.2024). **The tenderer shall not, during the said period, revoke or cancel the tender or alter the tender or any terms/conditions thereof.** In case the tenderer violates to abide by this, the Consulate will be entitled to take suitable action.

12. **Contract Agreement Document (s)**: This Tender Document shall be deemed to be part of the Contract Agreement.

13. **Sub-letting of work**: No subletting/out sourcing of work by the successful bidder is permissible.

14. **Payment**: Payment to the companies (successful bidders) for maintenance will be made either through bank transfer or cheque after the completion of maintenance/service of items demanded.

15. **Canvassing in Tender**: Canvassing in connection with the tenders in any shape or form is strictly prohibited and tenders submitted by such tenderers who resort to canvassing shall be liable for rejection

16. **Postponement or cancellation of tenders**: The Consulate reserves the right to postpone the date of receipt and opening of tenders or to cancel the tenders **without assigning any reason whatsoever.**
