- 3. The aforesaid Writ Peitions along with CM applications for interim relief came up for hearing on 17.01.2025 wherein the Hon'ble Court was please to pass following order:
- "The distribution of the remaining 507 Haj Quota seats, made vide paragraph 4 of the notice bearing no.Haj-15/5/2024-HAJ-MoMA issued by Ministry of Minority Affairs (Haj Division), Government of India dated 06.01.2025, shall be subject to further order(s) in the present petition."
- 4. In view of above, the distribution of quota and issue of certificate of allotment to waitlisted member HGOs of the CHGOs as per the aforesaid Notice dated 06.01.2025 are kept in abeyance till such time a final order is passed by the Hon'ble High Court in the matter.
- 5. In the meantime, the Ministry is pursuing the matter of allotment of additional quota with Kingdom of Saudi Arabia at the highest level.
- 6. This issues with the approval of the Competent Authority.
