The Consulate General of India, Jeddah invites sealed tenders/bids from Registered Transport Companies of Kingdom of Saudi Arabia for short term leasing of 2 Refrigerated pick up van (Double Cabin) not older than 2022 model with two Indian drivers (preferable) on each van and refueling of gasoline etc. for Haj 1447 H/ 2026 G.

2. Interested and eligible Pilgrim Transport Companies may submit their sealed bids in accordance with the procedure outlined in the Tender Document. The bids should be dropped in the Tender Box marked “**Tender Box**” placed at the **Reception of the Consulate General of India, Tahlia Street, Jeddah**. The offer must be submitted no later than **17.12.2025 by 1700 hrs**.

NOTICE INVITING TENDER

The Consulate General of India, Jeddah, invites sealed tenders/bids from the eligible bidders for short term leasing of 2 refrigerated pick-up vans not older than 2022 model with two Indian drivers (preferable) on each bus, refueling of gasoline, without mileage restriction and comprehensive insurance having requisite license/registration/permissions etc., with local compliance authorities.

Location of work	Makkah & Madinah
Purpose	For transporting medicines and medical equipment within Makkah & Madinah
Requirements	(i) The van is required to be equipped with refrigeration which could transport medicines as per the guidelines of the Ministry of Health, KSA (ii) Two Indian drivers (preferable) on each van (on 12 hrs duty), Gasoline Refueling by the company itself, Comprehensive Insurance, without mileage restriction & round the clock service etc. (iii) Only registered transport companies based in Jeddah, Makkah & Madinah which can get necessary permits to the drivers by ELM or any other authorized Saudi authorities for movement between Jeddah, Makkah & Madinah are eligible.

2.1 Auto extension of critical dates: If number of bids received is found to be less than 03 (three) on the end date of bid submission, the last date of bid submission and bid opening date of the Tender will be automatically extended for a period of 03 (three) working days ending at 17.00 hrs. The auto extension shall work on the basis of number of bids received only.

2.2 If any of the above extended dates falls on a Holiday i.e. a non-working day then the same is to be rescheduled to the next working day.

2.3 This extension will be also applicable in case of receipt of zero bid.

2.4 After extension, the tender shall be opened irrespective of available number of bids on the extended date of opening of tender, if they are less than 03 (three).

3. Pre-Bid Meeting: The purpose of the pre-bid meeting is to clarify the issues and to answer questions on any matter that may be raised at that stage regarding Tender. Non-attendance at the pre-bid meeting will not be a cause for disqualification of a bidder and it shall be presumed that the bidder does not require any clarification. The pre-bid meeting shall be held in Consulate General of India, Jeddah on the scheduled date & time. The bidder may also seek clarification over official e-mail within the specified period.

4. Eligibility of the bidder: The invitation for bid is open to all bidders including an individual, proprietorship firm, partnership firm, company registered with the Chamber of Commerce/Zakat, Tax and Customs Authority (ZATCA)/appropriate licensing authority of the Kingdom of Saudi Arabia.

5. General Essential Requirements: In order to qualify in the tender, the Bidders have to accept all the Terms and Conditions of the Tender Document unconditionally. The tenderer shall closely study the Tender Document.

5.1 Each Bidder shall submit only one Bid, either individually, or as a proprietor, or as a partner in a partnership firm. **A Bidder who submits or participates in more than one Bid will cause all the proposals with the Bidder's participation to be disqualified.**

5.2 The successful Bidder will be expected to complete the Work(s) by the Intended Completion period specified in the Tender document.

6. Submission of bid: Technical and Financial bids must be submitted in two separate duly sealed envelopes with “Technical Bid” & “Financial Bid” clearly mentioned on the envelopes. Both the envelopes should be placed in one large duly sealed envelope. Name of the Tender, Tender Reference No, Name and Address, e-mail, mobile number of the bidder should be written on the larger envelope containing the sealed envelopes with Technical & Financial bids respectively.

a. Technical Bid: Technical bid (in a sealed envelope) must consist of following documents/details:

- Copy of valid license and registration
- Copy of Company’s VAT Registration
- Copy of Bank IBAN letter of the Company
- Profile of the company, also reflecting experience in the field of transportation
- The total number of refrigerated vans in the fleet and their details.
- Istamarah copies of refrigerated pick up van being offered or proof of leasing of refrigerated pick up van in the preceding Haj year.
- Drivers on the sponsorship of the company or hired through Ajeer are only allowed and undertaking is required to be submitted

Note: If any of the aforementioned documents are submitted in Arabic, an “Official English Translation” of each document must be provided concurrently.

b. Financial bid: The financial bid should be submitted in the following format. **The rates quoted by the bidder should be exclusive of VAT. The financial bid which is incomplete and not submitted as per instruction given in this document is liable for rejection.** The rates and prices shall be quoted by the Bidder entirely in Saudi Riyal only.

6.1. Opening of bids:

The financial bid must be submitted on the company's official letterhead, duly signed and stamped by an authorized representative of the Company.

6.2 Disqualification Due to Overwriting or Zero Bid

Bidders are advised that any overwriting, alterations, or submission of a zero (0) bid in the financial bid shall lead to automatic disqualification. All entries in the Bid must be clear, unambiguous, and duly filled in accordance with the instructions provided in this Tender Document.

7. Opening of bids:

(a) A Tender Evaluation Committee (TEC) of the Consulate General of India, Jeddah will open the bids on 18.12.2025 at 11:00 hrs in the Consulate. Representatives of the bidders must attend the bid opening.

(b) TEC will first evaluate the Technical bids and, technically qualified bidders will be informed of TEC's decision and invited to be present for the opening of Financial bids. Thereafter, financial bids of only technically qualified bidders will be opened, in presence of representatives of technically qualified bidders. The EMD of the remaining bidders who could not meet the requirements of Technical bid would be returned after the bidding process.

(c) In case of more than one company quoting the same L1 rate, those companies will be asked to resubmit financial bids only rates lower than the original quote will be entertained.

7.1 Decision of L1 bidder & Issue of work order: The L1 bidder will be decided on overall Bid Value (Excluding VAT). **If L1 bidder backs out, the bidder will be debarred from participating in tenders floated by the Consulate General of India, Jeddah for minimum one (1) year.**

7.2 The approval for award of work to L-1 Bidder will be accorded by the Competent Authority. Only after such approval, the Letter of Acceptance/Work order to the L-1 Bidder will be issued.

7.3 On receipt of Letter of Acceptance (LOA)/Work Order of the tender issued by the Consulate, the successful tenderer shall execute the contract agreement within 15 days starting from the day the draft agreement is shared by the Consulate or as per the date/time indicated by the Consulate. **Failure to enter into the required contract within the specified period the work order/LOA shall be cancelled.** In addition, the Consulate may debar the bidder from participating in future bids for at least 12 months and the EMD/bid security would be forfeited.

8. **Bid Validity**: The validity period of the tenders shall be from the date of issue of work order to the end of Haj Season i.e. 15th Muharram 1448 H (corresponding to Gregorian 30.06.2026). **The tenderer shall not, during the said period, revoke or cancel the tender or alter the tender or any terms/conditions thereof**. In case the tenderer violates to abide by this, the Consulate will be entitled to take suitable action.
9. **Contract Agreement Document (s)**: This Tender Document shall be deemed to be part of the Contract Agreement.
10. **Sub-letting of work**: No subletting/out sourcing of work by the successful bidder is permissible.
11. **Payment**: Payment to the companies (successful bidders) for execution of the work will be made either through bank transfer or account payee cheque after the completion of works/services and submission of a valid VAT invoices.
12. **Canvassing in Tender**: Canvassing in connection with the tenders in any shape or form is strictly prohibited and tenders submitted by such tenderers who resort to canvassing shall be liable for rejection
13. **Postponement or cancellation of tenders**: The Consulate reserves the right to postpone the date of receipt and opening of tenders or to cancel the tenders **without assigning any reason whatsoever**.

7. I do hereby undertake that all the information being submitted by me/us is genuine, authentic, true and valid on the date of submission of tender and if any information is found to be false at any stage of tendering or contract period, I/We will be liable to the following penal actions apart from other penal actions prescribed elsewhere in the tender document.

a. Cancellation of my/our bid/contract (as the case may be)

b. Reasonable action as deemed fit by the Consulate

8. That I/we accept all terms and conditions of the tender document. I/We do not have relationship with any other participating Bidders, directly or through common third parties, that puts us in a position to have access to information about or influence on the bid of another Bidder.

9. I do undertake that if any information and document submitted is found to be false/ incorrect at any time, Consulate may cancel my/our Bid and action as deemed fit may be taken against me/us, including termination of the contract, forfeiture of all dues and banning of our firm and all partners of the firm etc as per the tender document for which I/We shall have no claims against Consulate.
